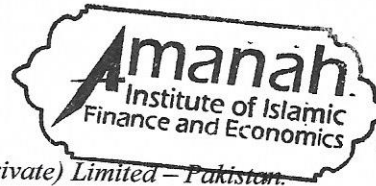


3. Next year re-audit will be conducted between October-November 2018 however, Amanah HRC may visit the production site for an unannounced audit without prior information to the company.
